### Summary of Objective<sup>1</sup>

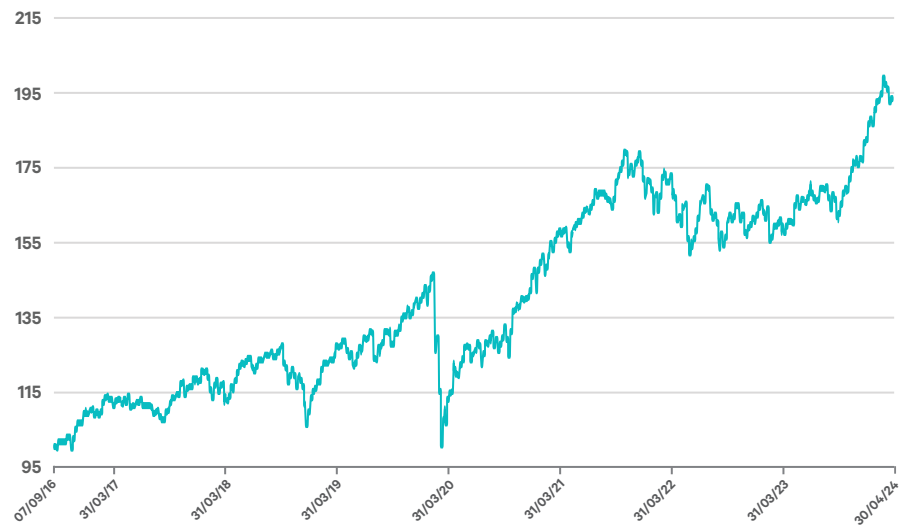

Figure 2: Asset Allocation

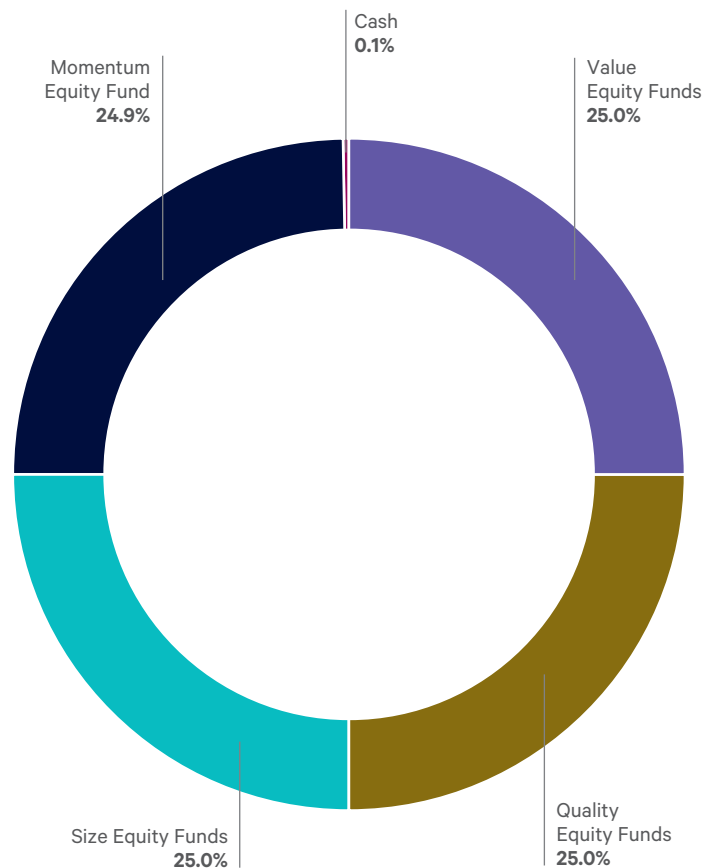
