### Summary of Objective<sup>1</sup>

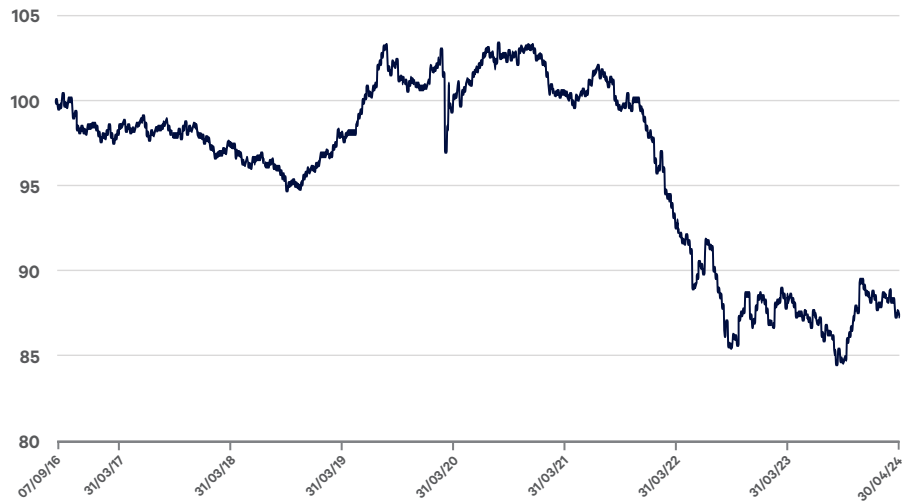

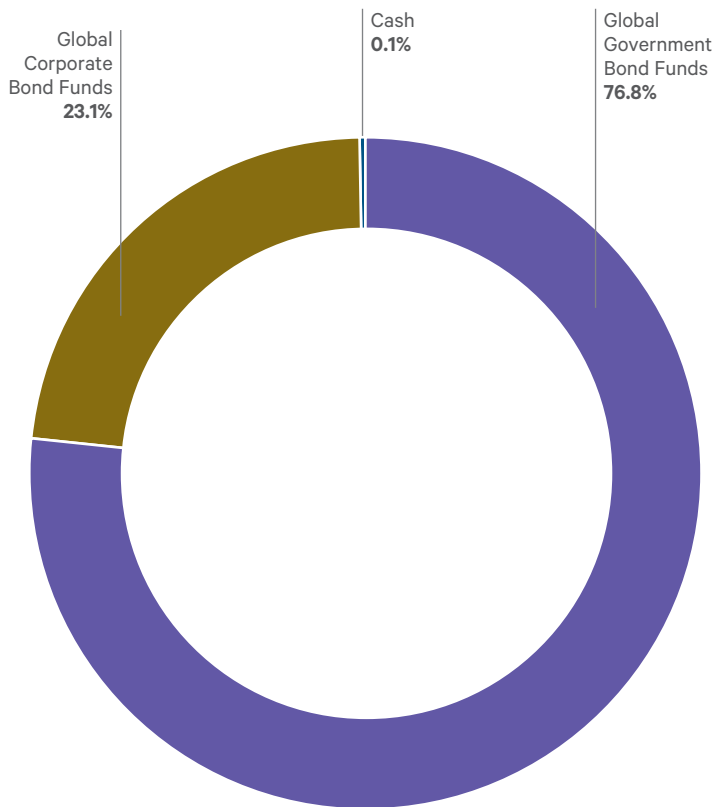
